### Information on the processing of personal data pursuant to art. 13 of Regulation (EU) 2016/679 (GDPR)

The Opera Pia Mastai Ferretti Foundation, as Data Controller, informs you that the processing of the data provided with this form, or in any case acquired for this purpose, is carried out for the processing of your request.

The legal basis on which this processing is based is to be found in the fulfilment of a legal obligation to which the Data Controller is subject (art. 6, parag. 1, lett. c of the GDPR) and the processing itself will be carried out in compliance with the principles of relevance and non-excessiveness also with the use of computerized procedures, guaranteeing the confidentiality and security of the data.

The processing will be carried out by employees and collaborators, including external ones, of the Data Controller as well as by subjects who provide services connected or instrumental to the purposes described above (e.g. technical services, ...). It is understood that these subjects will act as authorized/external data processors.

The personal data provided will be kept for the time strictly necessary for the investigation of the specific procedure and for the additional time necessary to ensure compliance with legal obligations. In addition, the preservation may continue in the event of judicial litigation and for the entire duration of the same.

Finally, the same data may be communicated to other public and/or private entities only by virtue of a provision of law or regulation that allows it.

Under no circumstances will the data be disseminated and/or transferred to third countries.

The provision of personal data, necessary for the pursuit of the above purposes, is free, however it is a requirement for the conclusion of the process of processing the request.

The processing of personal data will be carried out in compliance with the provisions of EU Regulation no. 2016/679, using computerized and manual methods, in order to guarantee the confidentiality and security of the same. To this end, specific technical and organisational security measures have been implemented and are constantly being applied to prevent the loss of data, to combat possible illicit or incorrect use and to avoid any unauthorised access by third parties.

No automated decision-making is adopted.
